IMPORTANT! KEEP FOR FUTURE REFERENCE

Yepp Easyfit is suitable for fitting on standard luggage carriers which are suitable for a maximum load of 25 kg and which comply with NEN 14872 (25 kg). The new method of installation on the side of the carrier means it is also suitable for most e-bikes.

The Yepp Easyfit is equipped with a special frame that allows the Yepp Maxi Easyfit child seat to be fitted straightaway.

The Yepp Easyfit can also be used together with the Yepp Junior, but the luggage carrier must then comply with NEN 14872 (35 kg).

MOUNTING

- The Easyfit comes pre-assembled. Position the Yepp Easyfit on the luggage carrier and tighten the bolts firmly after ensuring correct positioning. Tighten both bolts evenly in order to achieve optimum fixing.
- Check the bolts after a few weeks, and tighten if necessary.
- Following installation, the Yepp Maxi Easyfit can be fitted quickly and easily.

The position depends on the type and size of the bicycle, and the Yepp Maxi Easyfit's centre of gravity may never be more than 10 cm behind the rear axle (see also Yepp Maxi Easyfit instructions for use).

Advice: After installing and fitting the Yepp Maxi Easyfit, check whether there is a risk of the bicycle tipping over backwards when your child is placed in the seat. If that happens, you should move the Yepp Easyfit forwards. Check regularly to ensure that all fixings are properly secure.

WARNINGS

- Do not attempt to modify the carrier yourself, since this will void all guarantees and/or claims for liability.
- Always remove the seat when transporting the bicycle on a car bike carrier. Turbulence may damage the seat or the fixings, which could lead to an unsafe situation.
- Do not use the carrier if any part is broken. Have a broken part replaced by a professional.
- After installing check that everything has been installed correctly and that all the fixings are properly secure.
- After installing the Yepp Easyfit make a short test ride with the Yepp Maxi Easyfit in order to check that everything still works correctly on your bicycle.
- The Yepp Easyfit is only suitable for installation on luggage carriers which comply with EN14872 and are suitable for a load of at least 25 kg. If the Yepp Easyfit is used for the Yepp Junior, the luggage carrier must be suitable for a load of **35 kg**.
- Only use the Yepp Easyfit on a bicycle which is suitable for the additional load. Check the bicycle's user manual or consult the manufacturer or your cycle store.
- The Yepp Easyfit should never be installed on motorised vehicles (including mopeds, scooters, etc) apart from e-bikes.

SAFETY ADVICES

- If you want to carry cargo on the bicycle, place it in such a way that the weight is evenly spread across the bicycle. Matching saddlebags are available.

UK

- Make sure that you do not exceed the maximum weight.
- Do not leave your child in the seat unattended when you park the bicycle.
- Make sure that you have a good (double) kickstand.
- Check regularly that all fixings are sufficiently secure.
- Check that it is legal to use the Yepp Easyfit carrier in the country where you intend to use the Yepp Easyfit carrier.
- Regularly check that no parts of the body or items of clothing come near moving parts on the bicycle, such as a foot between the spokes or a finger in the braking mechanism.
- Always replace the carrier after an accident, even if there is no visible damage.
- The Yepp Easyfit is easy to clean with lukewarm soapy water. Never use aggressive cleaning agents.

GUARANTEE

Our products are guaranteed against defects in material and workmanship for one year after purchase. If you register your product on our website at www.yepp.nl the warranty is extended for an extra year. We will gladly replace the product free of charge if it has a manufacturing fault. If it cannot be expected to repair the product, we will replace the part to our sole discretion.

Who is covered?

The original purchaser who has purchased the product from an authorised dealer in the same country as the buyer. Proof of purchase is always required.

Production or material defects, whereby we have confirmed that the product has always been used under normal conditions as described in it.

What is not covered?

Second owner or modified products, poorly maintained products, improper or abnormal use, faded material, failure to follow the instructions, a child who is left unattended, safety harness not used, overloading, damage caused by transport, including air transport and freight. The instructions and that it has been properly maintained.

Costs to consumers within the warranty

The consumer is responsible for all postage required to send the product to the manufacturer or distributor for warranty and/or service.

Costs to consumers beyond the warranty

When proof of purchase cannot be produced or when the product is no longer covered by the warranty period of one year, the manufacturer (or distributor) is entitled to charge for service fees and/or costs related to the replacement/repair of parts. A fee may also be required to return the product.

Exceptions

Any consequential damage or injury to any person or property, directly or indirectly, resulting from use of the product.
